## **CONFLICT MINERALS STATEMENT**

Taylor Foundry Company (TAYFYCO®) hereby represents, warrants, covenants and certifies that it is in full compliance with all applicable conflict minerals laws, including, without limitation, Section 1502 of the Dodd-Frank Wall Street Reform and Consumer Protection Act of 2010, as it may be amended from time to time and any regulations, rules, releases, decisions or orders relating thereto adopted by the Securities and Exchange Commission or successor governmental agency responsible for adopting regulations relating thereto (collectively, the “Act”), and none of the Goods furnished hereunder shall contain any conflict mineral (including, but not limited to, tin, tantalum, gold and tungsten) originating in the Democratic Republic of the Congo or an adjoining country (the “Conflict Region”) or other high-risk area, unless such conflict mineral is from recycled or scrap sources or such conflict mineral was outside the supply chain prior to January 31, 2013. TAYFYCO® further agrees, at any time upon the Purchaser’s reasonable request, (1) to promptly certify in writing as to our compliance with this paragraph, (2) to promptly provide the Purchaser with such information regarding the source and chain of custody of all conflict minerals that may be contained in the Goods delivered hereunder, (3) to reasonably cooperate with the Purchaser’s efforts to comply with the requirements of the Act, and (4) to cause its subcontractors and sub-suppliers of every tier to provide us and the Purchaser with the information and cooperation that TAYFYCO® is required to provide under the foregoing clauses (1), (2) and (3). Should we learn or have reason to know of or suspect any development that makes it likely that any Good furnished hereunder contains any conflict mineral originating in the Conflict Region (includes the Covered Countries, Regions, and other High-Risk Areas) in violation of the foregoing, or that in any other way makes inaccurate, incomplete or misleading the representations, warranties and certifications of TAYFYCO® set forth herein, then we shall immediately advise the Purchaser in writing of such knowledge or suspicion and all related information known to us. TAYFYCO® acknowledges that the Purchaser will rely on the accuracy and completeness of information that we furnish to the Purchaser as the basis for the Purchaser’s compliance with the Act.
